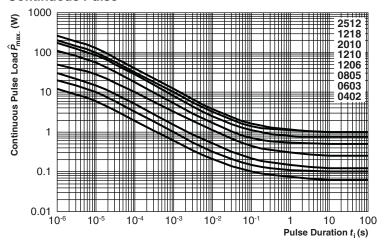

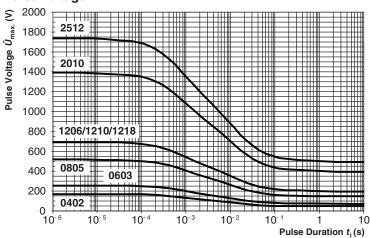

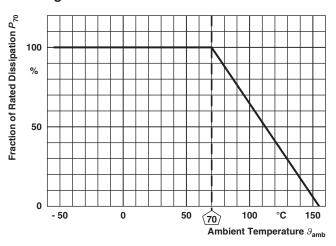
### **Pulse Voltage**



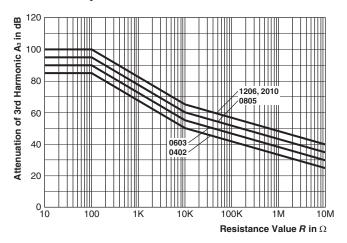

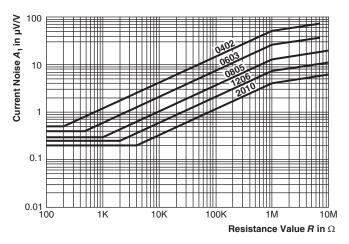
